Street Supervisor Dale Carroll said that Greg Hinson will try to provide the information about siding for the Eagle Community Center by the next meeting. Mayor Younger said that Poynor Concrete had been visiting the areas to be repaired the previous week.

Park Committee Chair Bett Jewell said that the Park Committee had met to discuss some of the immediate needs at the park and that the wheels are in motion on some solutions and projects. The committee also discussed some downed trees at the old horse track area (behind Eagle Community Center); Mayor Younger said that he'd contacted Dale Sowell about the trees since the trees are large and beyond the capacity for the street department to handle.


New Business
