Mayor's Report

Mayor Younger updated the board on a recent repair made to a sewer main on North Poplar St. Bradley Skinner noticed a spot in the road that he believed we should look at and ended up digging up about 20 feet of the road and replaced the main in that area. Our departments worked diligently until all repairs we completed.




